

### Check if plants you want to import from the EU are high priority

From 1 January 2021, new requirements will apply to UK imports of high priority plants and plant products from the EU. This includes the requirement for:

- Goods to be accompanied by a phytosanitary certificate;
- Import pre-notification to be submitted to the competent authority by the UK importer;
- Documentary and identity checks and physical inspection.

This list has been in effect since 1 January 2021.

\* We will require phytosanitary certificates from these countries listed, based on current information (i.e. those where the named pests are present).

In other cases the requirement for a phytosanitary certificate applies to the EU as a whole.
